CALL TO ORDER

PRESENT TO SPEAK

Suzanne Chapman: Good evening. My name is Suzanne Chapman. I've been a resident of Willington since 1987 and have worked for the town and the Board of Education, both as an employee and elected official. I currently serve as Registrar of Voters. I am commenting tonight solely as an individual, not as a member of any group or political party. I have a fairly clear understanding of how the town operates financially. Every year the Board of Finance requests that department heads submit budget proposals outlining what they need to efficiently and responsibly operate. Departments comply. They attend meetings, defend their budgets, explain their requests and outline the importance of what they're asking for. Then we start to hear the same old things;

the faces at the tables change, but the words never do. They're the same; keep spending flat, we can't afford it. Put it in CIP, keep the mill rate flat, residents on fixed incomes can't pay, we can't raise taxes this year because there's a pandemic, the economy is bad, inflation, more, pick a reason. There's always something. This town does not value its assets. There isn't a town owned building that is not in need of repair; I know, I've worked in them. A short time ago we held a meeting of the Tolland County Registrar of Voters in the Town Office Building. I was embarrassed by our facility. Its condition clearly shows our lack of interest in taking care of what we have. From the dirty floors to the warped and chipped tables, it's obvious we don't care. The town's biggest and most undervalued asset is its employees. This becomes glaringly obvious every budget season when experienced, qualified people are asked for what they need and are slapped down time and time again. Always trying to find a cheap way out, a band-aid to fix things for now. A prime example is the difficulty that we have had finding and keeping a qualified Assessor. Without a strong and well functioning Assessors and Revenue Collector's office, what do we have? No taxes assessed equals no taxes collected. I urge you to properly fund these offices. Our largest block of voters at elections and referendums are 50 to 80 years old. They vote for us and they vote for our budgets. Our budgets pass two to one. Our collection rate on taxes levied versus revenue collected is consistently in the high 90th percentile. Consistently. Even in years where there's a mill rate increase. I believe in fiscal responsibility and a conservative approach to spending. I tend to approach things from a logical point of view. Cutting budgets based on a dollar amount or percentage without examining the detail presented in each line item in my opinion is not logical. I want Willington to prosper and thrive. I implore you to listen to the people that work for you. This town cannot continue to function and thrive unless it is properly funded. Value your assets, value your staff. Submit a budget that is what we need to thrive and let the voters decide. Thank you.

Peter Latincsics, 97 Trask Road: Good evening. I have been a resident of Willington for 30 plus years. I've served on the Board of Finance, the Board of Education, Planning & Zoning, Capital Improvement Committee and various other committees. I want to comment tonight even before the public hearing, which is coming, that I was pleased to see the Board of Finance recognize that this two mill increase that we see currently in the budget as it stands, a 10% increase in spending, not a cut at all, but in fact a substantial increase over even the inflationary increases that we're seeing that are buffering the nation and our state and town. I attended the Selectmen's meeting and I was pleased to see Selectman Bulick attempt to respond to your direction from the last Board of Finance meeting. Unfortunately the majority on the Board of Selectmen did not agree and essentially are saying that these are the services they feel should be funded and there will be no effort to work in any way to find a common middle ground. I don't agree with that. I don't agree with what I'm hearing as a very shrill and consistent message from many corners that our town is underfunded, that past administrations didn't fund the town properly. Somehow as a community we were derelict for decades. This is not true. Our town has done an outstanding job of meeting our obligations and providing people with a reasonable tax bill and I encourage you to do that tonight. Thank you very much.

Robin Campbell, 33 Spak Road: I am also an employee of the Town of Willington. I serve the town as the Town Clerk and I am very honored to serve our town. I wanted to touch base on the current budget that has been submitted by the Board of Selectmen. I truly believe that the selectmen have put much thought into putting forth a good and true budget for this year. Selectman Boritz said it best at their meeting this past Monday; that there really isn't much that they can cut. And she also said that they've cut so many necessary expenses over the years based on the recommendations of the Board of Finance, where those cuts have ended up costing us more in the end. Suzanne Chapman also said it very well just a few minutes ago that our employees are our biggest asset and we sometimes do not feel valued in this situation. All of us that work in town office building, our jobs are set by statute and it seems as though every year the state adds more and more unplanned and unfunded mandates in which we have to put into our budgets and we have to cut and somehow work among it and it's very difficult. Lastly, I just want to say I do appreciate all of the work that the Board of Finance and all of our other boards and commissions do. I respect everything that you do and I know you all put hard work into every decision that you make. But I respectfully request that you put forth the budget that has been submitted and let the residents decide. Thank you.

Janice Clauson: Revenue Collector for the Town of Willington. I understand that a lot of members have an issue with the requested budget increase for the position of revenue collector. Part of it was a contracted raise that was in my contract when I was hired that I get a 2% increase when I complete my certification courses which I've done and when I'm actually sworn in with that certification, that 2% should come into play. I believe that is part of what has been included. The other portion of that is what was a placeholder for what the union contract was going to do... What my department head is earning should be rectified. What I'm asking for and what I would ask for any person is this position is that they are paid a fair wage compared to other like towns. Some towns like ours or that are smaller than Willington could be \$65,000/\$70,000.00 but the point is that this position has been underfunded for many years and something needs to be done about it. Thank you.

OLD BUSINESS

1) ARPA Process

On Monday the first set of projects to be considered for funding were presented at the public hearing. The Commission voted to approve the 6 projects presented. At the next meeting on April 4th, additional projects will be discussed. A second public hearing will be held at the end of April. Roughly \$1 million has been approved for projects. Project submissions are still being accepted at this time.

2) Moose Meadow Road repairs

First Selectwoman Wiecenski stated that the Board of Selectmen would like to request the Board of Finance appropriate funding for the Moose Meadow Road repair project. This work is estimated at \$298,000.00. With a 15% contingency for materials, etc, this estimates the project to cost roughly \$343,000.00. This work includes the cost of paving, stone, catch basins, piping, guardrail replacement, and the rental of an excavator to perform the work. The Board has not yet selected a vendor and is awaiting a third quote for the project. DPW Director Sposato stated that the culverts will be excavated, 500-feet of underdrain will be added, 9 catch basin tops will be installed, 387-feet of guard rail will be replaced, 3,900 feet of road will be reclaimed, and 1,400 feet of the road will have a 1 ½-inch overlay.

M. Makuch made a motion to that the Board of Finance moves to recommend the Board of Selectmen call a town meeting to appropriate \$350,000.00 from the capital reserve for the purpose of repairs to Moose Meadow Road.

People like working in the Town Office Building, they have good experiences, they have friends there, but I think they just can't justify staying when they know they can make a lot more money going elsewhere, across the town line to the next town and I know it's hard because we're a small town and it's frustrating.
