## First Selectwoman's Status Report

- A. STEAP Grant for OTH Septic: Still awaiting the engineering and RFP to be complete
- B. LOTCIP: Nothing new to report.

- C. ARPA: The ARPA Commission met on March 6th for the facilities study discussion. Closed on project for second ambulance at Willington number one which returned about \$3,200.00 back into the fund. We are still about \$2,800.00 short, if all projects were funded. There are a few projects still pending. There was a public hearing in which selectman CIP items were discussed which was a facilities study for town facilities, maintenance, structural as well as meeting the needs of the services in the town. ARPA voted to approve funds which will be used for the library, school, senior center, town of office building and potentially both fire departments.
- **D. GRAND LIST UPDATE:** Final number from 2022 Grand list is \$483,751.710.00 and is an increase of \$18,552.110.00 from 2021 which equated to approx. \$500,000.00 in additional tax revenue. Love's preliminarily added 5,547,000 to real estate and 2,076,220 to personal property, a total of 7,623,220. First Selectwoman Wiecenski commended the Assessor's office and the great job that Kara and Nicole are doing to get things cleaned up. Also, Selectman Bulick would like to know how the residential side is doing as there are many crumbling foundations that are being worked on. First Selectwoman Wiecenski will work on getting comparison numbers together.

- **F. FOIA** We did receive a FOIA request, and we are working on gathering the data with assistance from IT.

## **New Business**

## A. Resolution - Open Space and Watershed Land Acquisition Grant Agreement

We had a Grant application before DEEP for the Talmadge property, we were awarded the grant last June, and they are finalizing the process and preparing to release the funds.

## Fist Selectwoman Wiecenski moved the following resolution,

Whereas, the Town of Willington has applied for and received a grant, for financial assistance under the Open Space and Watershed Land Acquisition Grant Program (OSWA), established and administered by the State of Connecticut Department of Energy and Environmental Protection ("DEEP") pursuant to Section 7-131d of the Connecticut General Statutes.

Resolved, that Erika G. Wiecenski as First Selectman of the Town of Willington is hereby authorized to execute on behalf of the Town of Willington an Open Space and Watershed Land Acquisition Grant Agreement and a Conservation and Public Recreation Easement and Agreement for property known as Talmadge Estate (OSWA#624) with the DEEP, and to manage said land as open space land pursuant to Section 7-131d of the Connecticut General Statutes.

BE IT FURTHER KNOWN that Erika G. Wiecenski was elected as First Selectman on November 7, 2017, and her term of office began on November 21, 2017, and will continue until November 21, 2023. As the First Selectman, Erika G. Wiecenski serves as the Chief Executive Officer for the Town of Willington and is duly authorized to enter into agreements and contracts on behalf of the Town of Willington.

#### Selectman Makuch seconded.

#### Discussion:

Kathy Demers spoke via zoom and stated that this is the usual boiler plate type of grant agreement and conservation easement paperwork that the state requires when we receive open space money form them. Kathy also stated that the town attorney has looked through all the contracts and the still making adjustments to them before they will be signed. The grant is about \$81,000.00 in which the final piece of the property will be purchased. A 16-acre parcel on Mason Road which abuts the other Talmadge conservation as well as Knowlton track.

Stafford Mechanical Services coming in at \$10,518.76, EMCOR Services at \$7,250.00 and Energy Unlimited coming in at \$7,400.00. Public Works Director Troy Sposato recommended using EMCOR Services. The Town does currently have a contract with EMCOR services right now.

First Selectwoman Wiecenski moved to award the Vault Heating/ Cooling System Replacement to EMCOR Services in the amount of \$72,250.00.

# A. FY 23-24 Budget Update

First Selectwoman Wiecenski share that she was able to reduce the approved budget by \$6,518.00 for a new total of \$4,295,028.00 or 8.17% was 4,301,546.00 or 8.34%. Fuel prices were locked in with a significant reduction, based on Quantities of fuel that we purchase. Additionally, we lowered the overall Revenue Department budget by \$950 as a proposed fee increased will now remain flat. She shared those savings with the BOF at the budget presentation last week.
