- A. Love’s Travel Stop:** KD gave a report on the DEEP’s evidentiary hearings at DEEP in Hartford, CT concerning the Wastewater Treatment System at Love’s Travel Stop. The post hearing filing date is 6/15/18 which has been extended 4 weeks. The extension gives Love’s Travel Stop and DEEP staff time to send their revised plans and their rebuttals to comments presented at the public and evidentiary hearing to the DEEP Hearing Office. The Hearing Officer will then make a recommendation to DEEP and Love’s Travel Stop on the Wastewater Treatment System at Love’s Travel Stop.

 - 1.** “Connecticut Green Burial Grounds” is looking for a large piece of property to preserve as public open space. CGBG wants to establish Connecticut’s first “green cemetery”—a place reserved for burials without embalming, vaults, or any but a simple, natural, unpainted casket or shroud. They contacted WCC in hopes that we could help CGBG identify a potential site. KD contacted their representative and is waiting for a reply. Information will also be forwarded to the Willington Cemetery Association
