6. Updates on PREVIOUSLY FUNDED and OPEN requests
 - a. ARPA-10 - TOB Meeting Room Equipment - Mics & speakers (BOS) / Approved at Town Meeting on 8/3/21 for \$28,500.
 - b. ARPA-15 - Senior Center Coordinator Position (WHS) / \$34,379 was appropriated for this. The remaining 11,896.15 will be depleted in FY23-24.
 - c. ARPA-17/18 - Walking track improvements at RRAC (Drainage & lights) (WPRC) - \$220,000 / Approved at 8/1/22 meeting.
 - d. ARPA-21 - Fuel Bank and HH Heating (WHS) - \$25,000 was originally approved for this purpose. An additional \$10,000 was approved for the winter of 23/24.
 - e. ARPA-23 - Summer Camp Supplement (WHS & WPRC) Approved on 5/22 for \$36,238. The remaining \$14,442.31 will be depleted in FY23-24.
 - f. ARPA-27 - Building materials for park structure maintenance (WCC) / Approved on 5/24/22 for \$3,500. These funds may take several years to spend.
 - g. ARPA-29 - ARPA Commission Public Hearing Expenses (ARPA) (prior ARPA-28) / Approved on 5/24/22 for \$2,000. To date \$1,019.71 has been spent to hold 4 Public Hearings. \$980.29 remains to be used for future Public Hearings, if necessary.
 - h. ARPA-30 - Call for Service at Button Hill (WHA) Approved on 8/1/22 for \$53,000.
 - i. ARPA-31 - Historical Society Archival Storage (WHS) - \$15,000 / Approved at 8/1/22 meeting.

- j. ARPA-33 - Flags, Grave Markers and Monument Repair (WVF) - \$6,500 / Approved at 9/19/22 meeting. \$3,418.49 spent to date with invoices pending for full amount.
- k. ARPA-39A – Repair of Library Building Structure – Retaining Wall (WPL) \$13,000 / Approved at 1/23/23 meeting. Work was expected to be done in Spring of 2023.
- l. ARPA-41 – Stove for Senior Center (SC) \$6,000 / Approved at 1/23/23 meeting.
- m. ARPA-43 – Recess Equipment (BOE) \$6,000 / Approved at 1/23/23 meeting. \$549.16 spent to date.
- n. ARPA-44 – Extended Learning Opportunities (BOE) \$20,000 / Approved at 1/23/23 meeting. \$6,670.00 spent to date.
- o. ARPA-45 – Economic Development Strategic Plan (EDC) \$40,000 / Approved at 2/6/23 meeting. EDC working on finding a vendor.
- p. ARPA-46 – E-Code 360 (EDC & Town Clerk) \$10,000 / Approved at 1/23/23 meeting.
- q. ARPA-47 - Facilities Study (BOS) - \$50,000. / Approved at 3/6/23 meeting. BOS working on finding a vendor.
