- The Declaration is received by or postmarked later than Wednesday, November 1, 2023;
- The Declaration of Personal Property Affidavit on the back of this form is not signed by the owner or the owner's agent, if duly sworn to or notarized;
- > The Declaration is received on-time but property is omitted; or
- No Declaration is filed (Conn. Gen Stat. §12-41(e), §12-42).

The penalty CANNOT be removed by the Board of Assessment Appeals (Conn Gen Stat. §12-114, §12-119a).

<u>Filing Extension Request</u> – A request for a filing extension for good cause (§12-42) is possible if it is received before 11/1/2023. The request must be in writing or by email to nsnyder@willingtonct.gov.

If you no longer own the personal property assessed in your name or if you moved it out of Willington, return this declaration and provide information on the property's disposition (see below). Otherwise, the Assessor assumes you still own the property and failed to file.
