SNOW PLOWING TWO YEAR BID 2025-2027

*The following conditions shall apply to snow plowing and sanding services in the Town of Willington for the 2025 through the 2027 season.

- A. Submit bids for large trucks equipped with sanders.
- B. All trucks will have strobe lights on the truck or mounted on the sander. Minimum One (1) front, and one (1) rear. *Contractors must have a State of Connecticut flashing amber light permit.
- C. The Town of Willington will provide two-way radios and plows with blade replacements.
- D. Contractors must be on call twenty-four (24) hours a day, seven (7) days a week.
- **E.** Each Contractor will be assigned a route of several town roads.
- F. A minimum of three and one half (3 ½) hours call in time will be observed.
- G. No Contractor shall be released without the Public Works Director or designee being notified.
- H. All Contractors must have standby/backup drivers & trucks.
- I. The Public Works Director has the right to reject any driver (after contract is awarded).
- **J.** Contractors will punch in and out at Public Works. 1 hour travel time will be allotted for reporting to Public Works.
- **K.** Property damage will be the responsibility of the contractor and will be deducted from their payment.

*The following documents must be provided to be eligible for consideration:

- A. Certificate of Insurance & copy of drivers CDL's.
- B. Copy of truck registrations (all must be on file after the contract is awarded).
- C. Trucks will not be allowed to render their services until received by the town.
